This is with further reference to our previous letter dated 19th September 2016 on the above subject.

We wish to provide an update on the developments with the prospective Investor M/s. Vandell Financial Services SA. whose high level delegation arrived on 15th September 2016 to Sri Lanka.

The delegation met many VVIPs including His Excellency the President of Sri Lanka and the Honorable Minister of Finance, in addition to other fact finding missions to regulatory authorities. Among other issues discussed, the investors have expressed their desire to acquire 100% of the ownership of the company.

We have now submitted all the clarifications to the Investor delegation and awaiting their response from them in the form of a Memorandum of Understanding (MOU) indicating the future plan of action setting the milestones in reaching the final objective of reviving CIFL and handing over the management to the new investors.

Meanwhile, we give below the brief profiles of the investor delegation as provided in their communications:

2. **Honorable Hekga Gabriele Molitor (Mrs.)**

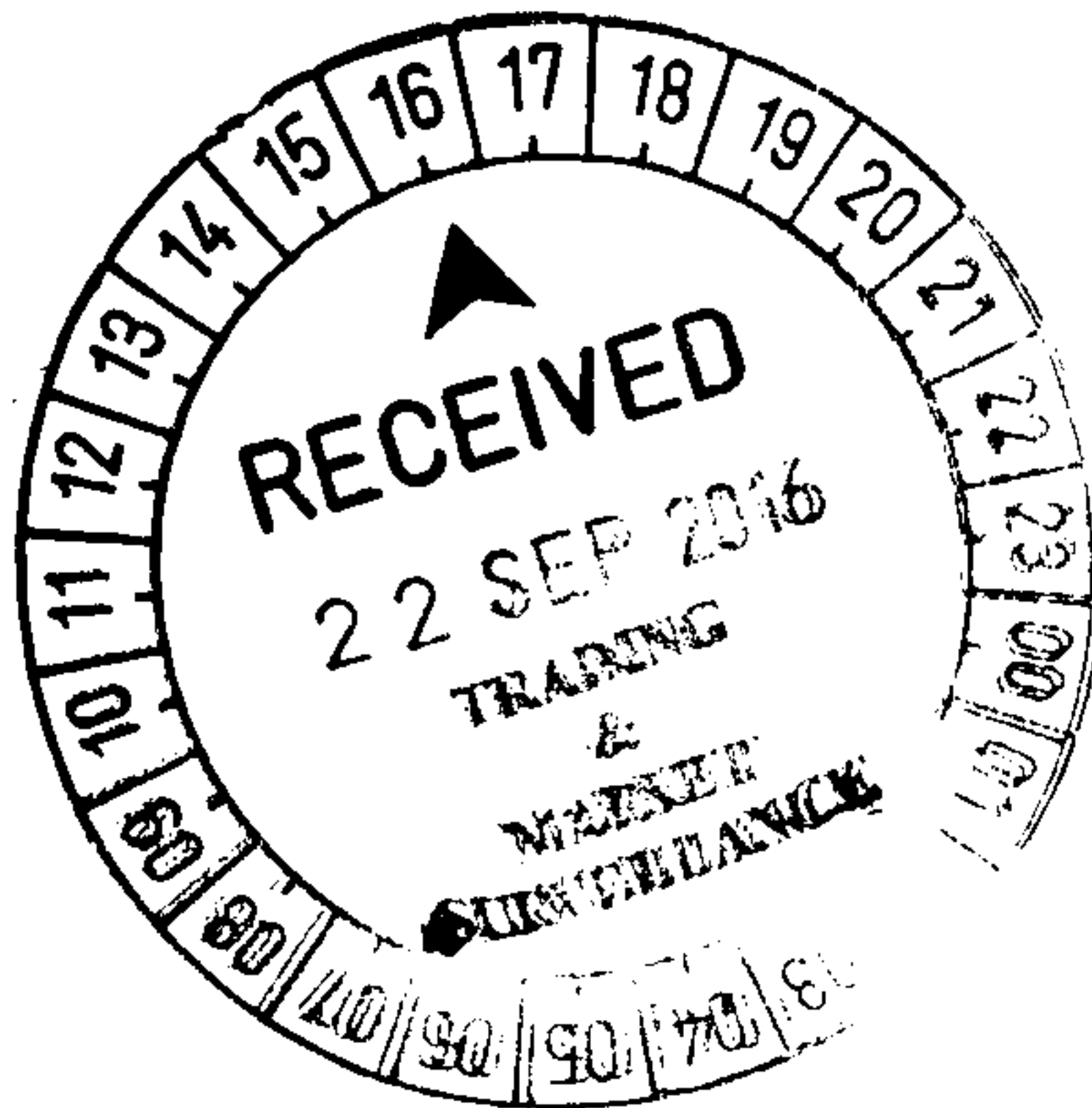
